**1. APOLOGIES FOR ABSENCE**

**2. DECLARATIONS OF INTEREST AND DISPENSATIONS**

**4. PLAYING FIELD**

**4.1 Steering Group:-** The Clerk reported that the Steering Group are now ready to go ahead with installing a Twin Castle Tower Climber on the playing field and an informal site meeting was held to agree on the position. It was **AGREED** that the Twin Castle Tower Climber would be installed between the play area and the basket ball court. The budget for this is £10,353 and the cost is £10,000. It was reported that the Trunch Village Society were unable to fund the cradle swing due to lack of funds. It was **AGREED** that this installation would not go ahead at the present time. The Clerk will action.

**4.2 Southrepps Football Club:-** The Clerk read an email from Southrepps Football Club requesting permission to use Trunch Playing Field on a Thursday for practice. It was **AGREED** that the Clerk would write to Southrepps Football Club and ask for a contribution of £10 per training session towards the upkeep of the playing field. The Clerk will ask Trunch Football Club, who have a lease agreement with Trunch Parish Council, which nights they train on the playing field.

**5. CORRESPONDENCE**

**5.1 Road Closure Notice:-** The Clerk reported that there will be a road closure for electricity works on 24<sup>th</sup> August on the Mundesley Road/Trunch Road junction for one day. Noted.

**5.2 Planning Training:-** The Clerk reported that there is a planning training session available which is very helpful. It was **AGREED** that the Clerk would arrange for this to take place and invite Trimmingham Parish Council and Swafield and Bradfield Parish Council to share the cost of £150.
